2. To set the compensation for town elected officials to be elected on April 7, 2009 and to hold the term of office from April 14, 2009 for two years pursuant to Section 60.32 of Wis. Statutes.
3. To authorize the town board to hire the town officers as employees of the town and set an hourly wage pursuant to Sec. 60.10(1)(g) of Wis. Statutes.
