**This Special Town meeting of the electors is called pursuant to Sec. 60.12 (1) (b) of the Wis. Statutes by the Town Board for the following purpose:**

- 1. To approve the 2014 total town tax levy to be collected in 2015 pursuant to s. 60.10(1)(a) of WI Statutes.**
- 2. To discuss/act on a resolution authorizing the town supervisors to exceed the total highway expenditure limit**
- 3. To set the compensation for town elected officials to be elected on April 7, 2015 and to hold the term of office from April 21, 2015 for two years pursuant to Section 60.32 of WI Statutes.**
- 4. To authorize the town board to hire the town officers as employees of the town and set an hourly wage pursuant to Sec. 60.10(1)(g) of Wis. Statues.**
